**ORDER:-**

In the reference 1<sup>st</sup> read above, Government have accorded permission to the Registrar, Yogi Vemana University for filling up of 118 vacant faculty positions in Yogi Vemana University and to take immediate necessary action for issue of appropriate recruitment Notifications, duly following the procedure laid down in the Act/Statutes/Regulations of the University.

2. In the reference 2<sup>nd</sup> read above, all the Vice Chancellors of 18 State Universities were informed that the Government, after due legal consultation feels that there is sufficient legal justification to withdraw the recruitment notifications. Accordingly, it was informed to place the matter before the Executive Council for taking necessary decisions in accordance with the respective Acts of the universities.

3. In the reference 4<sup>th</sup> read above, the Commissioner of Higher Education has informed that the Executive Council of Yogi Vemana University in its meeting held on 13-04-2026 resolved to withdraw the 2023 faculty recruitment notifications so as to initiate fresh faculty recruitment at the earliest, and requested to issue necessary instructions in this regard.

4. Government after careful examination of the matter, hereby withdraws the permission accorded for filling up of 118 vacant faculty positions in Yogi Vemana University vide reference 1<sup>st</sup> read above duly permitting the University to issue fresh notifications for faculty recruitment of vacant posts to be notified with due concurrence of Finance department and after addressing all the anomalies in this regard.
